UNIVERSITY OF ARKANSAS AT MONTICELLO STUDENT GOVERNMENT ASSOCIATION SPRING 2009 ELECTION RULES

Rule 1. ORGANIZATION OF ELECTIONS

SECTION 1.

There shall be two elections organized in the Spring 2009 semester; a general election and a special election.

SECTION 2.

The general election shall be organized to elect officials to fill open positions (as described in these rules) in the Student Government Association (SGA). The general election will be held, in compliance to the SGA Constitution, three days with the polls being located at a separate location each day; namely, Tuesday, April 14, 2009 from 10:00 AM to 2:00 PM at the Science Center (SC) Main Entrance, on Wednesday, April 15, 2009 from 10:00 AM to 2:00 PM at the Gibson University Center (UC) Green Room, and on Thursday, April 16, 2009 from 10:00 AM to 2:00 PM at the Memorial Classroom Building (MCB) Lobby.

SECTION 3.

The special election shall be organized for the student body to vote on ballot measures proposed either by students or the SGA Senate that will affect the SGA and the student body as a whole. The special election will be held, in compliance to the SGA Constitution, three days with the polls being located at a separate location each day; namely, Monday, March 23, 2009 from 10:00 AM to 2:00 PM at the Gibson University Center (UC) Green Room, on Tuesday, March 24, 2009 from 10:00 AM to 2:00 PM at the Science Center Main Entrance, and on Thursday, March 26, 2009 from 10:00 AM to 2:00 PM at the Memorial Classroom Building (MCB) Lobby.

Rule 2. OPEN POSITIONS

SECTION 1. OPEN POSTITIONS

Interested candidates may file for the following positions open for election in the Spring 2009 general election: SGA President, SGA Vice-President, SGA Secretary, SGA Treasurer, Student Activities Board (SAB) Position I, SAB Position II, SAB Position III, SAB Position IV, SAB Position VI, SAB Position VII, SAB Position VIII, College of General Studies Senate Position II (GSII), Division of Agriculture Senate Position II (ARGIII), School of Business Senate Position II (BUSII), Division of Computer Information Systems Senate Position II (CISII), School of Arts and Humanities Senate Position II (SAHII) (those degrees not in Art, Music, Speech, or Journalism), Art

Department Senate Position II (ARTII), Division of Music Senate Position II (MUSII), Speech and Journalism Department Senate Position II (SJII), School of Education Senate Position II (EDII), School of Forest Services Senate Position II (FORII), Biology Department Senate Position II (BIOII), Chemistry Department Senate Position II (CHEMII), Mathematics Department Senate Position II (MATHII), Natural Science Department Senate Position II (NATII), Pre-Medical Department Senate Position II (MEDII), Division of Nursing Senate Position II (NURII), Division of Military Science Senate Position II (MILII), Psychology Department Senate Position II (PSYII), History Department Senate Position II (HISTII), Criminal Justice Department Senate Position II (CJII), Department of Political Science/ Pre-Law Senate Position II (PSCIII), Sociology Department Senate Position II (SOCIII), Social Work Department Senate Position II (SWII), Anthrolopology Department Senate Position II (ANTHII), At-Large Senate Position III (ALIII), At-Large Senate Position IV (ALIV), and At-Large Senate Position V (ALV).

SECTION 2. SGA EXECUTIVE (CABINET) POSITIONS' DESCRIPTIONS

The powers, duties and responsibilities of the **SGA President** can be found in Article III, section 2 of the SGA Constitution.

The powers, duties and responsibilities of the **SGA Vice-President** can be found in Article III, section 3 of the SGA Constitution.

The powers, duties and responsibilities of the **SGA Secretary** can be found in Article III, section 4 of the SGA Constitution.

The powers, duties and responsibilities of the **SGA Treasurer** can be found in Article III, section 5 of the SGA Constitution.

SECTION 3. SGA SENATE POSITIONS' DESCRIPTIONS

The powers, duties and responsibilities of the **SGA Senator** can be found in Article IV of the SGA Constitution.

SECTION 4. SGA SAB POSITIONS' DESCRIPTIONS

The powers, duties and responsibilities of the **SAB Position I** shall be: to hold his/her office for one year term, to be elected by the student body at-large; to preside over the Student Activities Board; to have one vote in the Cabinet, only when a tie has occurred; to work with the Director of Student Programs and Activities and Vice-Chancellor of Student Affairs on matters of planning and scheduling activities on campus; and to insure quality, variety, and well-coordinated activities are presented for student involvement on campus.

The powers, duties and responsibilities of **SAB Positions II, III, IV, V, VI, VII, & VIII** shall be: to hold his/her office for one year term, to be elected by the student body atlarge; and to be a full active voting member of SAB.

Rule 3. FILING FOR OFFICE

SECTION 1.

<u>ALL CANDIDATES</u> interested in filing for office must fill-out a **Statement Pledge of Departmental Support Form**, notifying the Election Commission of the candidates' declared major and minor, as registered with Office of the Registrar; and a **Candidate Filling Form**, formally registering to run for a SGA office, and declaring the office in which the candidate wishes to file.

SECTION 2.

In order to appear on the ballot, all candidates must have **all forms and certified petitions filed** with the Office of the Director of Student Programs and Activities between Monday, March 9, 2009 8:00 AM and Friday, March 27, 2009 4:30 PM. Candidates who do not have all paperwork filed **BEFORE FRIDAY, MARCH 27,** 2009 4:30 PM shall not be placed on the ballot.

SECTION 3.

In order to appear on the ballot, a candidate filing **FOR A EXECUTIVE OFFICE OR A SAB POSITION** must obtain the **signature of fifty (50) students** on a certified petition provided by the Election Commission. Certified petitions may be obtained by filing a **Certified Petition Form** and must have attended at least five (5) SGA meetings per semester for two semesters concurring.

The offices of President and Vice-President shall be elected as one ticket. Candidates wishing to run for these offices, will have to select a running mate to file with in order to be on the ballot.

SECTION 4.

In order to appear on the ballot, a candidate filing **FOR A SENATE POSITION** must obtain the **signature of approval from the office seeking department's head**. The Election Commission will arrange department head signature opportunity.

SECTION 5.

All candidates must sign an agreement recognizing that the Election Commission is the authority over Student Government Association elections, and the commission's decisions can be appealed to the Student Senate. In addition, a candidate filing for office

must sign an agreement acknowledging he/she has read Article VII of the Constitution concerning the rules and regulations involved in the election process.

SECTION 6.

 All candidates must attend a **Mandatory Candidate Meeting**, hosted by the Election Commission on **Tuesday**, **March 31**, **2009 at 3:00 PM in the Gibson University Center (UC) Caucus Room**, to review all rules of the Spring 2009 general election; and to insure all candidates understand the election rules and process.

Rule 4. CAMPAIGNING

Campaigning shall be defined as any method of actively soliciting votes such as making speeches, and distributing literature, fliers, cards, posters, electronic communication and social networking mediums, or other campaign paraphernalia. There shall be absolutely no campaigning before the official beginning of the campaign period. **The campaign period shall begin Monday, April 6, 2009 12:00 AM.**

Rule 5. CAMPAIGN FINANCES

SECTION 1. SPENDING LIMIT

There shall be a limit of \$75.00 in expenditures per candidate. Each candidate shall fill out a campaign expenditure form, and sign a release authorizing the election commission to verify all expenditures and amounts. If a candidate receives any free goods or services to which the others in that race do not have access, the values of those goods and/or services will be counted against his/her campaign limit.

SECTION 2. FINANCE POOLING

Candidates willing to campaign with other candidates may do so with the following provisions: that all goods and/or services used in which more than one candidate directly benefits from, shall the equal cost value of the goods and/or services be counted against each candidate benefiting's campaign limit.

Rule 6. ELECTION AUTHORITY

SECTION 1. ELECTION COMMISSION

The University of Arkansas at Monticello Student Government Association Election Commission is the authority over Student Government Association elections. The Commission and The Election Commissioner, elected from the members of the Commission, shall have right to interpret election rules, constitution regulations, and SGA legislation to insure a au courant and fair election process. The Commission's decisions can be appealed to the SGA Senate, Director of Student Programs and Activities or the Vice Chancellor for Student Affairs.

APPENDIX

SGA CONSTITUTION ARTICLE VII

"ARTICLE VII ELECTIONS

SECTION 1. FILING FOR OFFICE

(A) In order to appear on the ballot, a candidate filing for executive office must obtain the signature of fifty (50) students on a form provided by the election commission. All candidates must sign an agreement recognizing that the election commission is the authority over Student Government Association elections, and the commission's decisions can be appealed to the Student Senate. In addition, a candidate filing for office must sign an agreement acknowledging he/she has read Article [VII] of the Constitution concerning the rules and regulations involved in the election process.

(1) Candidates must also agree to disclose their campaign expenditures, and make them available for verification by the commission.

(2) The filing period will close one week prior to the beginning of elections. An acknowledgement of having read Article [VII] must be turned in the SGA office by candidates prior to the end of the filing period.

(3) If any office is not filled, the newly elected President will then fill the vacancy in accordance with the guidelines of Article III, Section 2.

(B) Nominations for Student Senate will be made by the students of each department. There will be two seats per department listed in the current catalog plus two seats from the General Studies and five Members atlarge. Nominations will be as described in Article [VII], Section 1, Paragraph A, except twenty (20) signatures will be required to nominate.

SECTION 2. VOTE REQUIRED FOR ELECTION

(A) The candidate that receives the plurality of the ballots cast shall be elected to that office.

(B) Senate seats shall be won in descending order by the number of valid ballots cast for departmental and atlarge candidates until all seats are filled. Voters may cast ballots for any Senate candidate irrespective of department or atlarge candidate.

(C) Ballots will be invalid if votes are cast for more than one candidate for each of the executive offices or more than two candidates in any of the departments or more than five atlarge candidates.

(D) Writein votes are permitted for any executive office, departmental Senate 1 2 seat, or atlarge Senate seat. However, writein votes must conform to the rules set down in this section and writein candidates must fulfill all eligibility requirements 3 4 noted elsewhere in this Constitution in order to assume office. 5 6 SECTION 3. 7 Elections for Student Senate and Student Government Association Officers will 8 9 be held no earlier that midterm of the spring semester and no later than the last Student Senate meeting. The election will take place over three consecutive days 10 for students to cast their ballots. For each of the three voting days the poll shall be 11 at a different location. 12 13 SECTION 4. 14 15 All students voting must present a valid UAM ID card. 16 17 **SECTION 5** 18 19 20 The election commission shall consist of five members chosen by the Student Senate and who are not running for any elected office or two University 21 professional staff members appointed by the Vice Chancellor for Student Affairs. 22 23 SECTION 6. DUTIES OF THE ELECTION COMMISSION SHALL BE: 24 25 26 (A) To establish the times and places of all elections according to the guidelines of the Constitution. 27 28 29 (B) To provide for poll workers for the election and to ensure the security of ballots and the ballot boxes. 30 31 (C) To count the votes of the election. 32 33 (D) To enforce all election rules and guidelines. 34 35 36 (E) To hear and decide upon any and all protests and possible violations. 37 (F) To determine the consequences for election rules violations. 38 39 (G) To receive financial disclosures from all candidates, and to verify their 40 expenditures. 41 42 43 (H) To certify election results after all protests and violations have been resolved. 44 45 (I) To report to the Student Government Association on any and all election matters. 46

SECTION 7. THE FOLLOWING ELECTION RULES ARE HEREBY ESTABLISHED:

- (A) There shall be a limit of \$75.00 in expenditures per candidate. Each candidate shall fill out a campaign expenditure form, and sign a release authorizing the election commission to verify all expenditures and amounts. If a candidate receives any free goods or services to which the others in that race do not have access, the values of those goods and/or services will be counted against his/her campaign limit.
- (B) Any candidate making a campaigning in an academic class will he removed from the ballot and will be ineligible for any office in that election. Campaigning is defined as: any method of actively soliciting votes such as making speeches, and distributing literature, fliers, cards, posters, or other campaign paraphernalia.
- (C) No campaigning is allowed within a fiftyfoot vicinity of the polls during the election. Poll workers may not wear or display any campaign paraphernalia or actively campaign for candidates while working at the polls. Voters will be asked to remove campaign paraphernalia while voting.
- (D) Campaigning will begin earlier than one (1) week prior to the election. The specific date will be declared by the election commission.
- (E) Candidates may not place any literature (fliers, cards, posters, etc.) inside classrooms, on automobiles (except for their own), utility poles, trees, entrance doors to University facilities, or any other area deemed inappropriate by the Assistant Vice Chancellor for Student Affairs or the Vice Chancellor for Student Affairs.

SECTION 8.

All complaints, disputes, and official protests will be handled by the Director of Student Programs and Activities. All contests of the election must be received in writing prior to the election being certified by the Vice Chancellor for Student Affairs or his/her designee. Should an election commission be established through the Student Senate They must follow the following guidelines: After the filing of a complaint or discovery of a violation, the commission shall schedule a hearing according to the Senate Bylaws. All interested parties, and all involved parties, will be notified of the time and place for the hearing. Decisions of the commission will be made by a majority vote. There must be at least three members of the commission present and voting for any decision to be valid. The following sanctions are available to the commission:

(A) Formal reprimand, for violations of nonserious nature.

1	(B) Invalidation of the election and the ordering of a new election for
2	major violations and for problems pertaining to the administration of the
3	election that potentially could alter the outcome.
4	(C) Removal of the candidate from the ballot or elected position, for major
5	violations, which have occurred during the election process.
6	(D) Any combination of the above sanctions that the election commission
7	may desire to impose.

11	The decision of the election commission will be upheld or overturned by majority
